**Resolution No. 2020-52**

**WHEREAS**, the Department of Budget and Management-Bids and Awards Committee (DBM-BAC) conducted a Public Bidding for the Project, "Courier Services," with an Approved Budget for the Contract of P7,000,000.00 for FYs 2021 and 2022, through the authorized appropriations under the FY 2021 General Appropriations Act and Multi-Year Contractual Authority No. MYCA-BMB-C-19-0000005, as reflected in the Indicative Annual Procurement Plan, CY 2021;

**WHEREAS**, as part of the DBM's early procurement activities authorized under Section 7.6 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, the proposed budget under the FY 2021 National Expenditure Program was used as basis;

**WHEREAS**, an Invitation to Bid for the Project, to cover the requirements for FYs 2021 and 2022, was posted on the Philippine Government Electronic Procurement System (PhilGEPS) website, the DBM website, and all DBM bulletin boards on October 27, 2020;

**WHEREAS**, two (2) prospective bidders attended the Pre-bid Conference on November 3, 2020, namely: (i) LBC Express, Inc.; and (ii) Premier Logistics, Inc.;

**WHEREAS**, Supplemental/Bid Bulletin No. 1 was issued on November 10, 2020 to clarify, modify or amend items in the Bidding Documents;

**WHEREAS**, during the submission and opening of bids on November 17, 2020, no bidder submitted a bid;

**WHEREAS**, in order to determine and address the reason for the failed bidding, the BAC initiated a mandatory review and requested the end-user unit, the Administrative Service, to evaluate the terms, conditions, and specifications in the Bidding Documents, including its cost estimates, pursuant to Section 35.2 of the 2016 Revised IRR of RA No. 9184;

**NOW, THEREFORE**, for and in consideration of the foregoing premises, the BAC **RESOLVED**, as it hereby **RESOLVED**, the following:

- 1) to declare the bidding for the Project, "Courier Services," as "failed" in accordance with Section 35.1(a) of the 2016 Revised IRR of RA No. 9184; and

- 2) to conduct a re-bidding, and reposting pursuant to Section 21.2 of the 2016 Revised IRR of the aforementioned law.
