BIDS AND AWARDS COMMITTEE

Resolution No. 2020-53

WHEREAS, the Department of Budget and Management-Bids and Awards Committee (DBM-BAC) conducted a public bidding for the Project, "Replacement of Tiles and Repainting of the Interior Walls and Finishes of Budget Information and Training Service and Budget and Management Bureau-B Offices," which is composed of the following: Lot 1 - Replacement of Tiles and Repainting of the Interior Walls and Finishes of Budget and Management Bureau-B Office, and Lot 2 - Replacement of Tiles and Repainting of the Interior Walls and Finishes of Budget Information and Training Service Office, with Approved Budgets for the Contract of P2,000,000.00 and P1,800,000.00, respectively, with a total of P3,800,000.00, authorized under the FY 2020 General Appropriations Act;

WHEREAS, as a background, the Invitations to Bid for the Project were posted on the Philippine Government Electronic Procurement System (PhilGEPS) website, the DBM website, and all DBM bulletin boards on August 11, 2020 and September 29, 2020, but failures of bidding were declared on September 11, 2020 under BAC Resolution No. 2020-43 and on October 20, 2020 under BAC Resolution No. 2020-47, respectively;

WHEREAS, on October 27, 2020, the third Invitation to Bid was posted on the PhilGEPS website, the DBM website, and all DBM bulletin boards;

WHEREAS, only one (1) prospective bidder, Dassan Cavite, attended the Pre-bid Conference on November 3, 2020;

WHEREAS, Supplemental/Bid Bulletin No. 1 was issued on November 10, 2020 to clarify, modify or amend items in the Bidding Documents;

WHEREAS, during the submission and opening of bids on November 17, 2020, three (3) bidders submitted their respective bids for both Lot 1 and Lot 2, namely: (i) Interworld Enterprises (Interworld); (ii) MMEEN Construction (MMEEN); and (iii) LPNA Construction (LPNA);

WHEREAS, after preliminary examination of the bids for Lot 2, the BAC, using non-discretionary "pass/fail" criteria, determined the following:

- 1) the submission of MMEEN as "failed" for its failure to submit the Revised Omnibus Sworn Statement, with ten (10) clauses, as prescribed in the 6th edition of the Philippine Bidding Documents for the Project;

- 2) the submission of LPNA as "failed" for its failure to submit a current and valid Tax Clearance Certificate, pursuant to Section 8.5.2 of the 2016 Revised IRR of RA No. 9184, as reiterated in Section 23.1 (a) (iii) of the same IRR; and
- 3) the submission of Interworld as "failed" due to a patently insufficient Bid Securing Declaration Form, pursuant to item 3.2, Appendix 10 of the 2016 Revised IRR of RA No. 9184;

WHEREAS, the foregoing BAC determination is in accordance with Section 30.1 of the 2016 Revised IRR of RA No. 9184 which provides that bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as "failed";

WHEREAS, in order to determine and address the reason/s for the failed bidding, the BAC initiated a mandatory review, and requested the end-user unit, the Administrative Service, to evaluate the terms, conditions, and specifications in the Bidding Documents, including its cost estimates, pursuant to Section 35.2 of the 2016 Revised IRR of RA No. 9184;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC **RESOLVED**, as it hereby **RESOLVED**, the following:

- 1) to declare a third failure of bidding for Lot 2 of the Project, "Replacement of Tiles and Repainting of the Interior Walls and Finishes of Budget Information and Training Service and Budget and Management Bureau-B Offices," pursuant to Section 35.1(b) of the 2016 Revised IRR of RA No. 9184; and
- 2) to conduct a re-bidding, and reposting for Lot 2 of the Project as provided for in Section 21.2 of the same IRR.
