Resolution No. 2020-59

WHEREAS, the Department of Budget and Management-Bids and Awards Committee (DBM-BAC) conducted Public Bidding for the Project, "Renewal of Licenses for the Subscription of Google Suite," with an Approved Budget for the Contract of P13,000,000.00 through the authorized appropriations under the FY 2021 General Appropriations Act, as reflected in the Indicative Annual Procurement Plan, CY 2021;

WHEREAS, for the purpose of early procurement authorized under Section 7.6 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, the proposed budget under the FY 2021 National Expenditure Program was used as basis;

WHEREAS, an Invitation to Bid for the Project, to cover the requirements for FY 2021, was posted on the Philippine Government Electronic Procurement System (PhilGEPS) website, the DBM website, and all DBM bulletin boards on November 3, 2020;

WHEREAS, no prospective bidder attended the Pre-bid Conference on November 10, 2020;

WHEREAS, Supplemental/Bid Bulletin No. 1 was issued on November 17, 2020 to clarify, modify or amend items in the Bidding Documents;

WHEREAS, during the submission and opening of bids on November 24, 2020, no bidder submitted a bid;

WHEREAS, Section 35.1 (a) of the 2016 Revised IRR of RA No. 9184 provides that the BAC shall declare the bidding a failure when no bids are received;

WHEREAS, in order to determine and address the reason for the failed bidding, the BAC initiated a mandatory review and requested the end-user unit, Information and Communications Technology Systems Service, to evaluate of the terms, conditions, and specifications in the Bidding Documents, including its cost estimates, pursuant to Section 35.2 of the 2016 Revised IRR of RA No. 9184;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC **RESOLVED**, as it hereby **RESOLVED**, the following:

- 1) to declare the bidding for the Project, "Renewal of Licenses for the Subscription of Google Suite," as "failed" in accordance with Section 35.1 (a) of the 2016 Revised IRR of RA No. 9184; and
- 2) to conduct a re-bidding, and reposting pursuant to Section 21.2 of the same IRR.
