Resolution No. 2020-65

WHEREAS, the Department of Budget and Management-Bids and Awards Committee (DBM-BAC) conducted Public Bidding for the Project, "Supply and Delivery of Executive Laptops," with an Approved Budget for the Contract of P3,120,000.00 through the authorized appropriations under the FY 2020 General Appropriations Act, as reflected in the Supplemental Annual Procurement Plan No. 11;

WHEREAS, an Invitation to Bid for the Project was posted on the Philippine Government Electronic Procurement System (PhilGEPS) website, the DBM website, and all DBM bulletin boards on November 24, 2020;

WHEREAS, two (2) prospective bidders, namely: (i) Advance Solutions, Inc.; and (ii) Quartz Business Products Corporation, responded to the said Invitation and attended the Pre-bid Conference via videoconferencing on December 1, 2020;

WHEREAS, Supplemental/Bid Bulletin No. 1 was issued on December 8, 2020 to clarify, modify or amend items in the Bidding Documents;

WHEREAS, during the submission and opening of bids on December 15, 2020, no bidder submitted a bid;

WHEREAS, Section 35.1 (a) of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184 provides that the BAC shall declare the bidding a failure when no bids are received;

WHEREAS, in order to determine and address the reason for the failed bidding, the BAC requested the end-user units, Administrative Service-General Services Division and Information and Communications Technology Systems Service, to evaluate of the terms, conditions, and specifications in the Bidding Documents, including its cost estimates, pursuant to Section 35.2 of the 2016 Revised IRR of RA No. 9184;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC **RESOLVED**, as it hereby **RESOLVED**, to declare the bidding for the Project, "Supply and Delivery of Executive Laptops," as "failed" in accordance with Section 35.1 (a) of the 2016 Revised IRR of RA No. 9184.
