WHEREAS, the Department of Budget and Management-Bids and Awards Committee (DBM-BAC) conducted a public bidding for the Project, "Administration of Psychometric Exams for DBM Applicants and Employees," with an Approved Budget for the Contract of P1,896,600.00, authorized under the FY 2020 National Expenditure Program;

WHEREAS, under Resolution No. 2019-64 dated November 22, 2019, the BAC declared the first bidding for the Project as "failed" in accordance with Section 35.1(b) of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184;

WHEREAS, on November 26, 2019, the Invitation to Bid was posted on the Philippine Government Electronic Procurement System website, the DBM website, and all DBM bulletin boards;

WHEREAS, Supplemental/Bid Bulletin No. G-1 was issued on December 2, 2019 for all Projects included in the December 3, 2019 Notice of Meeting to postpone all BAC activities scheduled on the same date;

WHEREAS, only one (1) prospective bidder, People Dynamics Inc., responded to the said Invitation and attended the Pre-Bid Conference on December 10, 2019;

WHEREAS, Supplemental/Bid Bulletin No. 1 was issued on December 16, 2019 to clarify, modify or amend items in the Bidding Documents;

WHEREAS, during the submission and opening of bids on December 23, 2019, only one (1) bidder, People Dynamics Inc., submitted a bid;

WHEREAS, after preliminary examination of the bid, the BAC, using non-discretionary "pass/fail" criteria, determined the submission of People Dynamics Inc. as "passed" for complying with all the eligibility and technical requirements as stated in the Bidding Documents;

WHEREAS, after evaluation of the financial proposal, the BAC declared the submission of People Dynamics Inc. as the Single Calculated Bid in the amount of P1,397,000.00;

WHEREAS, after careful evaluation, validation and verification of the eligibility, technical and financial proposals of the bid, the BAC found that the submission of People Dynamics Inc. passed all the criteria for post-qualification; thus, it was declared as the Single Calculated and Responsive Bid in the amount of P1,397,000.00.

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC **RESOLVED**, as it hereby **RESOLVED**, to recommend to the Secretary of the Department of Budget and Management that the contract for the Project, "Administration of Psychometric Exams for DBM Applicants and Employees," be awarded to People Dynamics Inc., in accordance with Republic Act No. 9184 and its 2016 Revised Implementing Rules and Regulations.
