Resolution No. 2021-17

WHEREAS, the Department of Budget and Management-Bids and Awards Committee (DBM-BAC) conducted Public Bidding for the Project, "Procurement of HP Back-up Solution," with an Approved Budget for the Contract of P18,500,000.00 through the authorized appropriations under the FY 2021 General Appropriations Act, as reflected in the Annual Procurement Plan, CY 2021;

WHEREAS, on March 2, 2021, the Invitation to Bid was posted on the Philippine Government Electronic Procurement System (PhilGEPS) website, the DBM website, and all DBM bulletin boards;

WHEREAS, three (3) prospective bidders, namely: (i) Integrated Computer Systems, Inc. (Integrated Computer); (ii) Phil-Data Business Systems, Inc.; and (iii) Unison Computer Systems, Inc. (Unison), responded to the said Invitation and attended the Pre-bid Conference via videoconferencing on March 9, 2021;

WHEREAS, Supplemental/Bid Bulletin No. 1 was issued on March 16, 2021 to clarify, modify or amend items in the Bidding Documents;

WHEREAS, during the submission and opening of bids on March 23, 2021, two (2) bidders submitted their bids, namely: (i) Unison; and (ii) Integrated Computer;

WHEREAS, on March 23, 2021, after preliminary examination of the bids, the DBM-BAC, using non-discretionary "pass/fail" criteria, determined the submissions of Unison and Integrated Computer as "passed" for complying with all the eligibility and technical requirements as stated in the Bidding Documents;

WHEREAS, after evaluation of the financial components of the bids, the bidders were ranked according to their bid submissions:


WHEREAS, the DBM-BAC accordingly declared the submission of Integrated Computer as the Lowest Calculated Bid in the amount of P15,565,458.00;

WHEREAS, after verification, validation, and ascertainment of all statements made and documents submitted by Integrated Computer, using non-discretionary criteria, as stated in the Bidding Documents, the DBM-BAC determined that the submission of Integrated Computer passed all the criteria for post-qualification.

NOW, THEREFORE, for and in consideration of the foregoing premises, the DBM-BAC **RESOLVED**, as it is hereby **RESOLVED**, the following:

- 1) To declare the bid of Integrated Computer Systems, Inc. for the Project, "Procurement of HP Back-up Solution," in the amount of P15,565,458.00 as the Lowest Calculated and Responsive Bid, in accordance with Section 34.4 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184;
- 2) To recommend to the DBM Secretary, as the Head of the Procuring Entity, that the contract for the Project be awarded to Integrated Computer Systems, Inc. in the above-mentioned amount, in accordance with Section 37.1.1 of the 2016 Revised IRR of RA No. 9184; and
- 3) To notify all other bidders, in writing, of the DBM-BAC's recommendation within three (3) calendar days from the issuance of the resolution recommending award of the contract, pursuant to Section 37.1.1 of the 2016 Revised IRR of RA No. 9184.




