TERMSANDCONDITIONS (PURCHASEORDER)

1. ALL PRICES QUOTED HEREIN ARE VALID. BINDING AND EFFECTIVE AT LEAST WITTIN THIRTY CONCALENDAR DAYS FROM DATE OF ORIOTATION

- 2. AWARDIE shall be responsible for the source(s) of his supplies/material/equipment and shall make deliveries in accordance with schedule, quality and specifications of the award and parelisse order (PO). Failure by the AWARDEE to comply with the same shall be ground for cancellation of the award and parelisse order (NO). Failure by the AWARDEE and for re-awarding the items) to the Next Lowest Responsive Proposal, as determined by the DBM Bids and Awards Committee and approved by the Secretary of Budget and Management or his duly authorized representative.
- 3. The Goods shall only be delivered by the Supplier at the Property Section, General Services Division of the Procuring entity's Administrative Service located at Ground Phon, DBM Bidg. III., Gen. Solino St., San Miguel, Manita., not later than 1000 am up to 3 00 pm on the date of delivery as indicated in PO.

Moreover, the delivery schedule as indicated in the PO may be modified at the option of the Procuring Fatity, with preor due notice, we men or verbal, to the Supplier.

- 4 Subject to the provisions of the preceding pungraph, where AWARDFE has accepted a purchase order but finited to deliver the required productive within the time cated for in the same order, he shall be extended a maximum period of fifteen (15) calendar days to make good his delivery. Thereafter if AWARDEE has not completed delivery within the extended period, the subject purchase order shall be cancelled and the award for the undelivered balance withdrawn from the AWARDEE, without prejudice to the imposition of hquidated damages. The DBM shall then purchase the required from such other sourcets) as it may determine, with the difference in price in be charged against the DEFAULTING AWARDEE. Refusal by the DEFAULTING AWARDEE to shoulder the price difference shall be ground for his disqualification from future bids of the same or all items, without prejudice to the imposition of other sourcions as prescribed under R.A. 9184 and its IRR.
- 5. The Goods delivered are accepted by the Procuring Entity as to quantity only. However, impection as to the Goods' compliance with the technical specifications, and its order and condition, will be done in the presence of the representatives of both Supplier and Procusing Endity within three (3) working days from the date of delivery upon prior due notice, written or verbal, to the authorize representative of the Supplier. The inspection will push through as scheduled even in the absence of the Supplier's representative, if the latter was duly notified. In which case, the results of the inspection conducted by the Procuring Entity shall be final and binding upon the Supplier.
- 6. Rejected deliveras shall be construed as non-delivery of product(s) frients) so endered and shall be, if applicable, subject to liquidated damages and to the terms and conditions
- 7. Supplier shall guarantee the deliveries to be free from defects. Any defective near(s)/product(s) that may be discovered by the DBM within seven (7) working days after acceptance of the same shall be replaced by the supplier within seven (7) working days or until stocks are available upon receipt of a written notice. Beyond the said time frame, defective units will be picked up by the supplier for assessment.
- 8. A penalty of me-tenth of me percent (0.001) of the cost of the imperformed position for everyday of delay,

The maximum deduction shall be ten percent (19%) of the amount of contract. Once the cumulative amount of liquidated damages reaches ten percent (19%) of the amount of the contract, the procuring entity may reschad the contract, without preparate contract and remedies open to it. The Procuring Entity may also resemd the contract and impose 1973 of the attribute of the contract as liquidated damages, upon non-performance by the Supplier of my of its obligations under the contract

The imposition of liquidated damages in all instances shall be automatic, except apon prior respect for extension and approval thereof by the Precuring Pathy before the scheduled delivery date. Any request for extension not acted upon before delivery date shall be consulered denied.

- 9. All dimes, excise and other investiond revenue charges, if any, shall be for the supplier's account
- 10. The technical specifications, bid proposal and other documents required from the AWARDEE stall form part of this Purchase Order.
