#### **BIDS AND AWARDS COMMITTEE**

#### Resolution No. 2024-97

**WHEREAS**, the Department of Budget and Management-Bids and Awards Committee (DBM-BAC) conducted a Public Bidding for the Project, "Subscription to Online Learning Platform for One (1) Year," with an Approved Budget for the Contract of P9,468,000.00, through the FY 2025 National Expenditure Program (NEP), as reflected in the Indicative Annual Procurement Plan, CY 2025;

**WHEREAS**, for the purpose of early procurement authorized under Section 7.6 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, the proposed budget under the FY 2025 NEP was used as basis;

**WHEREAS**, on October 22, 2024, the Invitation to Bid for the Project was posted on the Philippine Government Electronic Procurement System (PhilGEPS) website, the DBM website, the official DBM Facebook page, and all DBM bulletin boards;

**WHEREAS**, four (4) prospective bidders, namely: (i) Asea Metrics HR Solutions, Inc. (Asea Metrics); (ii) Yapster eLearning, Inc. (Yapster); (iii) MyBusybee Inc.; and (iv) SD Publications, Inc., attended the Pre-bid Conference on October 29, 2024;

**WHEREAS**, Supplemental/Bid Bulletin No. 1 was issued on November 5, 2024 to clarify, modify or amend items in the Bidding Documents;

**WHEREAS**, during the submission and opening of bids on November 12, 2024, two (2) bidders submitted their bids, namely: (i) Yapster; and (ii) Asea Metrics;

**WHEREAS**, after preliminary examination of the bids, the DBM-BAC, using non-discretionary "pass/fail" criteria, determined the submissions of all bidders as "passed" for complying with all the eligibility and technical requirements as stated in the Bidding Documents;

**WHEREAS**, after evaluation of the financial components of the bids, the bids were ranked based on the bid submissions to identify the Lowest Calculated Bid, as follows:

1. Asea Metrics - P7,912,128.00 2. Yapster - P8,486,660.00

**WHEREAS**, the DBM-BAC accordingly declared the submission of Asea Metrics as the Lowest Calculated Bid in the amount of P7,912,128.00;

**WHEREAS**, after verification, validation, and ascertainment of all statements made and documents submitted by Asea Metrics, using non-discretionary criteria, as stated in the Bidding Documents, it was determined that the submission of Asea Metrics passed all the criteria for post-qualification.

**NOW, THEREFORE**, for and in consideration of the foregoing premises, the DBM-BAC **RESOLVED**, as it is hereby **RESOLVED**, the following:

- 1) To declare the bid of Asea Metrics HR Solutions, Inc. for the Project, "Subscription to Online Learning Platform for One (1) Year," in the amount of P7,912,128.00 as the Lowest Calculated and Responsive Bid, in accordance with Section 34.4 of the 2016 Revised IRR of RA No. 9184;
- 2) To recommend to the DBM Secretary, as the Head of the Procuring Entity, that the contract for the Project be awarded to Asea Metrics HR Solutions, Inc. in the above-mentioned amount, in accordance with Section 37.1.1 of the same IRR;
- 3) To notify all other bidders, in writing, of the DBM-BAC's recommendation within three (3) calendar days from the issuance of the resolution recommending award of the contract, pursuant to Section 37.1.1 of the same IRR; and
- 4) To issue the Notice of Award to Asea Metrics HR Solutions, Inc. upon the approval and effectivity of the FY 2025 General Appropriations Act, pursuant to Section 7.6 of the 2016 Revised IRR of RA No. 9184.

# CONTRACT No. 2025-02 SUBSCRIPTION TO ONLINE LEARNING PLATFORM FOR ONE (1) YEAR

### **CONTRACT AGREEMENT**

THIS AGREEMENT made this \_\_\_\_ day of \_\_\_\_ 20\_\_\_ between the **DEPARTMENT OF BUDGET AND MANAGEMENT** of the Philippines (hereinafter called "the Entity") of the one part and **ASEA METRICS HR SOLUTIONS, INC.** of Makati City, Philippines (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly Subscription to Online Learning Platform for One (1) Year, and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of Seven Million Nine Hundred Twelve Thousand One Hundred Twenty-Eight Pesos (P7,912,128.00) (hereinafter called "the Contract Price").

#### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- 2. The following documents as required by the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, *viz.*:
  - i. Philippine Bidding Documents (PBDs);
    - i. Schedule of Requirements;
    - ii. Technical Specifications;
    - iii. General and Special Conditions of Contract; and
    - iv. Supplemental or Bid Bulletins, if any
  - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the

# contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

- 3. In consideration for the sum of Seven Million Nine Hundred Twelve Thousand One Hundred Twenty-Eight Pesos (P7,912,128.00) or such other sums as may be ascertained, **ASEA METRICS HR SOLUTIONS, INC.** agrees to deliver the Subscription to Online Learning Platform for One (1) Year in accordance with its Bid.
- 4. The **DEPARTMENT OF BUDGET AND MANAGEMENT** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
- 5. The period for the performance of the obligations under this Contract shall not go beyond the validity of the appropriation for this Project.
- 6. In compliance with item 4.3 of Appendix 33 of the 2016 Revised IRR of RA No. 9184 and consistent with Administrative Order No. 34, s. 2020 (Directing Strict Compliance By All Agencies and Instrumentalities of the Executive Department with Transparency, Accountability and Good Governance Policies and Measures in the Procurement Process), the DBM shall publish in its official website and social media platform the following post-award information:
  - (a) Project name;
  - (b) Approved budget for the contract;
  - (c) Contract period;
  - (d) Name of the winning bidder and its official business address;
  - (e) Amount of contract awarded;
  - (f) Date of award and acceptance; and
  - (g) Implementing office/unit/division/bureau of the concerned agency or instrumentality.
