BAC Resolution Declaring Lowest Calculated and Responsive Bid, and Recommending Award of Contract for the "Supply and Delivery of Safe, Purified Drinking Water and Water Dispenser for FY 2025"

## RESOLUTION No. 2025-03-015

WHEREAS, the Department of Budget and Management ROVIII-BAC issued Request for Quotation (RFQ) to three (3) bonafide local suppliers namely: CRYSTAL CLEAR WATER REFILLING STATION, COOLBLUE WATERS, and QUALIPURE WATER STATION for the "Supply and Delivery of Safe, Purified Drinking Water and Water Dispenser for FY 2025" thru Negotiated-Small Value Procurement with a total Approved Budget for the Contract (ABC) of \$\int 28,000.00\$;

WHEREAS, the RFQs were duly acknowledged and received by the above suppliers;

WHEREAS, in response to the said request, two (2) suppliers namely CRYSTAL CLEAR WATER REFILLING STATION and COOLBLUE WATERS submitted their quotation within the deadline of bid submission; while QUALIPURE WATER STATION only acknowledged receipt but did not submit quotation;

WHEREAS, the quotations received were evaluated by the Committee on a "per lot" basis;

WHEREAS, upon careful examination of the quoted/bid, CRYSTAL CLEAR WATER REFILLING STATION was found to have offered the Lowest Calculated and Responsive Bid, as indicated in the attached Abstract of Quotation;

**NOW, THEREFORE,** We, the members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a.) To declare CRYSTAL CLEAR WATER REFILLING STATION as the bidder with the Lowest Calculated and Responsive Bid for the "Supply and Delivery of Safe, Purified Drinking Water and Water Dispenser for FY 2025" and Recommend award of contract to the said supplier with a total contract price of ₱28,000.00;
- b.) To specify in the Notice of Award (NOA) that processing of payment shall be subject to compliance with the required documentary requirements provided in the procurement terms and conditions of the RFQ; and
- c.) To recommend for approval by the <u>REGIONAL DIRECTOR</u> of the <u>DEPARTMENT</u> OF <u>BUDGET AND MANAGEMENT ROVIII</u> the foregoing findings and recommendation.
