BAC Resolution Declaring Single Calculated and Responsive Bid, and Recommending Award of Contract for the "Procurement of CY 2025 Courier Services"

## **RESOLUTION No. 2025-01-002**

WHEREAS, the Department of Budget and Management ROVIII-BAC issued Request for Quotation (RFQ) to four (4) bonafide local suppliers namely: LIBCAP SUPER EXPRESS CORPORATION, SOUTH SEAS CARGO, 2GO EXPRESS INC., AND AP CARGO LOGISTICS CORPORATION thru Negotiated-Small Value Procurement with a total Approved Budget for the Contract (ABC) of P60,000.00.

WHEREAS, the RFQs were duly acknowledged and received by the above-mentioned four (4) suppliers;

WHEREAS, in response to the said request only LIBCAP SUPER EXPRESS CORPORATION submitted its quotation within the deadline of bid submission while SOUTH SEAS CARGO, 2GO EXPRESS INC., AND AP CARGO LOGISTICS CORPORATION only received the RFQ but did not submit quotation;

WHEREAS, the quotations received were evaluated by the Committee on a "per lot" basis;

WHEREAS, upon careful examination of the quoted/bid, LIBCAP SUPER EXPRESS CORPORATION was found to have offered the Single Calculated and Responsive Bid, as indicated in the attached Abstract of Quotation;

**NOW, THEREFORE,** We, the members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a.) To declare LIBCAP SUPER EXPRESS CORPORATION as the bidder with the Single Calculated and Responsive Bid for the "Procurement of CY 2025 Courier Services" and Recommend award of contract to the said supplier with a total contract price of \$\mathbb{P}59,950.00;
- b.) To specify in the Notice of Award (NOA) that processing of payment shall be subject to compliance with the required documentary requirements provided in the procurement terms and conditions of the RFQ; and
- c.) To recommend for approval by the <u>REGIONAL DIRECTOR</u> of the <u>DEPARTMENT OF BUDGET</u>
  <u>AND MANAGEMENT ROVIII</u> the foregoing findings and recommendation.
