BAC Resolution Declaring Single Calculated and Responsive Bid and Recommending Award of Contract for the project "Delivery of Janitorial Services"

RESOLUTION No. 2024-12-081

WHEREAS, the Department of Budget and Management ROVIII thru its Bids and Awards Committee (BAC) has conducted procurement activities for the project "Delivery Janitorial Services" with a total ABC of ₱651,306.00 thru competitive public bidding;

WHEREAS, two (2) suppliers purchased the bid documents, namely, Vision Janitorial and Allied Services Inc and A&B Multi Serv Corporation and both have subsequently submitted their bid within the deadline of submission on November 27, 2024;

WHEREAS, upon evaluation of the eligibility and technical documents, A& B Multi Serv was declared failed bidder in view of the following:

As attachment to the Omnibus Sworn Statement, the Secretary's Certificate and per Resolution No. 19-2024, Re: Resolution No of the Board of Director's of A&B Multi Serv Corporation Authorizing a Representative to Participate in Bidding and Granting Full Power and Authority, the appointed representative for Region 8 is Ms. Anelyn M. Salandino. However, the submitted Eligibility and Technical Documents of the bidder bears the name and signature of 'Eden B. Añes' which is inconsistent to the Resolution No. 19-2024";

WHEREAS, a notice was served to A&B Multi Serv Corporation but the bidder did not submit Request for Reconsideration within three (3) days from receipt of notice;

WHEREAS, the bid of Vision Janitorial and Allied Services Inc. passed the preliminary evaluation and was declared by the BAC as the Single Calculated Bid subject to post qualification process;

WHEREAS, results of the post qualification showed Vision Janitorial and Allied Services Inc. responsive with the procurement requirements per attached post qualification report;

WHEREAS, the subject procurement project is undertaken through Early Procurement Activities (EPA), hence, the award of contract to the Lowest/Single Calculated and Responsive Bid may only be made by the Procuring Entity upon approval and effectivity of the FY 2025 General Appropriations Act (GAA) pursuant to Section 7.6 of the 2016 Revised IRR of RA 9184 and the provisions under GPPB Circular 06-2019 dated July 17, 2019;

NOW, THEREFORE, We, the members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

a.) To declare Vision Janitorial and Allied Services Inc as the bidder with the Single Calculated and Responsive Bid and Recommend Award of Contract to the said supplier with a total contract price of P609,859.44 for the "Delivery of Janitorial"

Services" subject to the approval and effectivity of the 2025 GAA and the provisions under GPPB Circular 06-2019 dated July 17, 2019, as applicable;

b.) To recommend for approval by the <u>REGIONAL DIRECTOR</u> of the <u>DEPARTMENT</u> <u>OF BUDGET AND MANAGEMENT ROVIII</u> the foregoing findings and recommendation.
